## **IO79 WILLIAM SOMMERWILL**

Copy of the will of William Sommerwill late of the Parish of Swimbridge in the County of Devon, Carpenter, Deceased. Executrixes: Elizabeth Sommerwill Spinster and Susanna Gaydon the wife of Alexander Gaydon both the same place. Proved in the Consistorial Registry of the Lord Bishop of Exeter 21st July 1825. Effects sworn under 200. Will made 18th March 1825.

To daughter Elizabeth: "a plot of Ground being part of my tenement the East side of the Turnpike and adjoining the Parish Lands and on the North by the Parish highway to her During her Life and if Married for her Husband to have the same During his Life and if no Children to return to my Executricses."

To daughters Mary Burgess and Susanna Gaydon: a plot of orchard ground "part of my Tenement in Swymbridge Village lying to the North End of the Turnpike Bridge and joins with the late John Upton's Orchard." All household furniture, goods, chattels. The brewing utensils were to remain with Susanna "as long as she remains in the Publick house and no longer, then to be parted between" Mary and Susanna.

To Elizabeth, Mary and Susanna equally: "all my Tenement Bills, Bond Notes or any thing else" (i.e. income from his properties). Also rents from his leasehold tenement in Chittlehampton.

If Elizabeth never married "nor never having no lawful children" all her rights were to return to Mary and Susanna.

Philip Somerville of Plymouth Dock, Devon, Esq., a Post Captain in HM Royal Navy.

Trustees: Wife Rosanna Byron Somerville

James Litle of Plymouth Dock, a surgeon in the Royal Navy John Erskine Risk of Saltash in Cornwall, Doctor of Medicine

Executrix: Wife Rosanna Byron Somerville

## Bequests:

- 1. To grandson Philip Somerville, relict of his late son Wm Hugh S., deceased (now residing with my wife's brother John Connor Field of Adderbury Park in Oxfordshire) debt of £300 owed to him from John Connor Field on security of promissory note, plus interest. Appoints JCF as trustee for PS in case he is still a minor, to use as much as necessary for his maintenance and education and then to pay the £300 (or residue) on him reaching 21. If PS dies before 21, the £300 is to be given to JCF.
- 2. To son John Somerville, Lieutenant in HM Navy
  - freehold messuage outhouses garden stable and hereditaments in Tamerton Foliott, late in possession of Peter Budd (bankrupt). To JS and his heirs and assigns.
  - a leasehold dwelling house, no 71 George Street, Plymouth Dock, occupied by Mr Davis, house carpenter, to hold during his term and interest therein, subject to rents, conditions etc owed to the Lord of the Manor of Stoke Damerel, and also subject to an annuity chargeable to Mrs Elizabeth Grigg of Youghall in Ireland
  - the household furniture and effects at the house in Tamerton Foliott and the library of books which may be at Plymouth Dock, Tamerton Foliott or elsewhere
- 3. To son George Field Somerville £1000 stock in Consolidated Annuities, in lieu of an annuity of £30 secured at George Somerville's marriage with Mary Hodge. To be transferred one year after testator's death.
- 4. To James Litle and his wife Mary £1000 stock, in lieu of claims which may be made by James Litle and Mary in respect of £250 (balance remaining on £1000 promised on their marriage), and in respect of interest on the £1000.
- 5. To daughter Rosina Young Somerville £1500 stock, to be transferred one year after death of the testator.
- 6. To wife Rosanna Byron Somerville and other trustees £1500 stock, to be transferred after one year upon trust for his daughter Rosina Young. Dividends to be paid to her during her life for her own use. Stock to be held by the trustees, after Rosina's death, in trust for the beneficiaries nominated in Rosina's will, or to her heirs.
- 7. To son James Bowen Somerville, a midshipman in the Royal Navy
  - £2000 stock, to be transferred after one year
  - Leasehold dwelling house, 86 Duke Street, Plymouth Dock, occupied by Henry Denham, grocer, for all the estate and interest therein subject to rents etc.
  - Premises and money to go to trustees during his minority. Dividends to be used for maintenance and education.
  - Should he die under age of 21, bequeaths the stock and house to all his living children equally, as tenants in common.
- 8. To daughter Sarah Frances Field £1500 stock, plus £1500 to the trustees upon trust as above. Trustees to pay maintenance etc while under age.

Residue to go to his wife unless she remarries. If she remarries, residue to go to living children in equal shares. Dividends in first year after decease to form part of residuary estate.

Administration granted to Rosanna Byron Somerville.

Remaining administration granted (27th May 1858) to James Byron Somerville, administrator of Rosanna Byron Somerville's estate (George Field Somerville having been Rosanna's surviving executor, who had died and left a will but no executor).

# Will of Hugh Somerville 12th July1816

Will of Hugh Somerville, Purser in the Royal Navy belonging to His Majesty's Ship the Queen Charlotte, lying in harbour at Portsmouth.

Sole executrix: his daughter Elizabeth Somerville

Bequests: To his daughters Elizabeth, Dorothea and Diana: all his estate and "monies secured either in the Public Fund of the three per Cents Consols and five per Cents Navy or elsewhere" to be equally divided between them. If they are not able to divide the inheritance satisfactorily among themselves they should appoint two friends to assist "but I strongly recommend them to settle the same in an Affectionate way in preference to calling in" such assistance.

## Addition made 20th August 1816 at sea

Wishes the expenses of his funeral to be met from his estate, for the funeral to be "both plain & quiet with every Aeconamy", and if circumstances permit to be "laid in the Vault at Alverstoke with my long beloved but departed wife". Mentions that his property "is but small". If any of the three daughters is married at the time of his death, the property (funds, furniture, plate, china, glass and paintings) is to be divided between the unmarried since the married will have a provider and protector. If all are married, the property is to be shared equally between them. If a married daughter dies leaving a child or children before the division of the property, the child or children shall receive the mother's share. Mentions houses and land and reiterates main provisions of the 12th July will.

## Memorandums added 21st August 1816

#### Bequeathes:

To his eldest daughter Elizabeth: "Family Paintings & Pictures Family Bible History of New Testament & Books of Prayer together with the Piano Forte & what belongs thereto my Favourite Bedstead the Hangings & footstools with the little China Shell Ornaments"..."Coffee Pot Sugar Bason & Tongs belonging thereto Large waiter Snuffer Stand & Snuffers the large set and small sets of Plated Castors one Pr Plated Castors Dinner tranch Candlesticks Plated Vegetable Dishes & Silver Soup Ladel and one set of Plain Salt Spoons with one Bed Candlestick mark'd with Crest & Tea Can (?) and one pair of Butter Laddles [sic]"..." All Articles of Plate or Plates things not directed for my other Daughters I leave to Elizabeth together with the Table set of Knives & forks which I wish for General use while living together if Seperated for Elizabeth also the Gravy Spoons"

To his second daughter, Dorothea: Painted Ornaments of Glass Valued Worked Table Five Spoons and set of Work Tables ...together with ottomans & Firescreens... Tea Pot & small waiter Cream Jug one pair of Butter Ladles Snuffer Stand [—] and Plated Snuffers one pair of large Candlesticks a Pair of Plated Casters and a set of Engraved Salt Spoons & Plated Caddie & Spoon"

To his third daughter Diana: "The Desert Cut Glass and Bagatelle Table and Stand"... "the Apern Complete Blue & Silver Glass Sugar & Cream Basons with Sugar Tongs & Ladle Coffee Biggin Silver Butter & Cheese Knives & Marrow Spoon one large pair of Candlesticks & one Bed Ditto"

"Silver Table & Desert Spoons and Forks to be equally divided Tea Spoons not worth Dividing"

"To Elizabeth all other parts of my property "

"Any favourite article of their Dear & beloved Mother my beloved Girls I trust will liberally and affectionately divide without grudging or Confined Ideas - liberality and [—] I trust will ever exist between my beloved Daughters as I love them all alike I hope my present anxious State does not, will not, occasion any unequal distribution if it does I hope neither [——] to partiality it being a distribution from Consideration to the Unprotected & a General love for all Let love & affection reign the relief & hope of which will reconcile my Situation and make me ready to meet an Angel Mother which I hope thro' the Patience & Mercy of the Almighty [—] of Even I may deserve before I am called hence it will greatly tend to happiness in every point So/To(?) [—] my beloved house (?) Amen - - Hu Somerville./."

"My Cloathes may be sent out of the way as early as possible & given at the discretion of Elizabeth with the A[—]ance of my Dora & Diana and divided between such as they see stand in need - My Fowling Piece fishing tackle &ca together with my Silver Moullted Small Sworn (?) to be given to Capt Fanney/Tanney(?) should he become the Husband my Dear Diana with any other Manly Article not Servicable or [—]ed by my other two Daughters [-] Hu: Somerwille./.

My Watch Chain & Seals I give my Daughter Elizabeth who I rely on to be kind & liberal as the Excuse to my other two beloved daughters[-] Hu: Somerwille./.

I further will and desire that in the event of my leaving more Furniture than may be necessary for the use of my Unmarried Daughters residence in such Case my eldest Daughter with the Consent of one of her Sisters may dispose of any[-] articles they may see proper and the Sum arising therefrom to be Shared agreeable to my foregoing Will and directions [-] Hu: Somerville./."

**Proved** at London with two Codicils 24th November 1817 before the Judge by the Oath of Elizabeth Somerville Sp'r the Dau' & Extrix to whom adm'on was granted being first Sworn by Com'on duly to Adm'r -

John Somerwill of the parish of Thelbridge, a neighbouring place to the south-west of the said parish of Witheridge, of free condition, forty years of age and more according to him, in which parish of Thelbridge he was born, spending his life in the same place up to the day of this present inquiry, having been admitted (etc), agrees with John Knyghston in all these matters. He is not (a hired man?) (etc).

## FEUDAL AIDS 1284-1431 (West Country Studies Library)

On 25th March 1428 the Commons made a grant to the King of tonnage and poundage, and also laid a tax on parishes and towns throughout England, graduated in proportion to the sums at which their respective churches were taxed for ecclesiastical tithes (tenths). When the value of the church was under ten marks the parish was assessed at 6s 8d and so on in proportion. There was also a levy of 6s 8d on every knight's fee in England (except lands assessed at under a quarter of a knight's fee). This is a tax record, arranged by county and then by hundred.

John Thilbrige, Thomas Wodhouse and John Somerwill hold half a knight's fee in Thylbrigge and Chadmore, which they hold separated amongst themselves, and none of them holds the whole four parts, and which was previously held, from a long time ago, by Margery Dynelegh (correctly Bynelegh).

## DEVON MUSTER ROLL FOR 1569, ed. A.J. Howard & T.L. Stoate (Indexed. Copy at Society of Genealogists)

Each year on a particular day able-bodied men assembled so that the number of fighting men could be counted and the state of their weapons assessed.

The entries follow a common pattern for each parish. First are given the 'Presenters sworen', about four of the most prominent men in the parish. Their names are followed by, 'who do presente (as aforesaid)...' and a list of main officers, often the same names as the presenters, with a list of their arms. 'The inhabitants not particularlie chardged are acessed to fynde and maynteyn ...' (a further list of items, eg one caliver, one murrion). Then are given 'the names of all thabell menne within the said parish of ... mustered'. These are listed as archers, harquebusiers, pikemen and billmen.

'The manor of Swimbridge belongs to the Duke of Bedford. Ernsborough gave name to a family who possessed that manor at an early period. They were succeeded by the Flavells, whose heiress brought it to Sir John Mules, a younger son of the Lord Mules, and it continued in his family for several generations. One of the co-heiresses of the last Sir John Mules brought it to Dabernon, and the heiress of Dabernon to Gifford (Westcote).

In 1773, it was the joint property of Mr Lewis Somerville and William Berry, Esq., of West Buckland. This estate has been for some time in the family of Hole, and is now the property of Henry Hole, Esq., of Ebberly.'
